Monitoring of Blue Swimming Crab Fisheries Improvement Program in Madura, Restocking, and Handover the Crab Apartment

APRI, Bappenas, UNDP, Agency of Marine Affairs and Fisheries of East Java Province, and the Brackish Water Aquaculture and Fisheries Center of Jepara done the monitoring of blue swimming crab fisheries improvement program in Madura waters, restocking, and handover the temporary shelter of egg berried female blue swimming crab (crab apartment) on September 20-21, 2019. Fisheries Improvement Program (FIP) keep trying to keep up the blue swimming crab sustainability in Indonesia.



Restocking activity done with releasing the 250,000 crablets in Baddurih Village waters, Pamekasan, Madura. Furthermore, also done the handover of 10 units of crab apartment to the fishermen of Pagagan Village, Pamekasan, Madura. This activity was also filled by the sharing about blue swimming crab fisheries management in Madura by Executive Director of APRI Dr. Hawis Madduppa, continued by sharing session with Mr. Mustain who is one of Jepara fishermen that was succeed to implement the crab apartment in his area. About Us

The organization APRI - whose members include over 30 seafood industry businesses and processors - covers more than 85% of purchased crab in Indonesia. All members involved are working to promote not only sustainable crab harvest, but a sustainable supply chain as well. The FIP aims to support scientific research through collaborations with universities, to develop a national Fishery Management plan through a partnership with the Ministry of Marine Affairs and Fisheries, and to establish community based fishery management by working with local fishing communities. The FIP is meant to have a lasting impact on the sustainability of the fishery's supply chain, on blue swimming crab resources, and also on the ecosystem where the species is harvested.



FIP Objective(s)

- Work plan and transition Indonesia Blue Swimming Crab Fisheries to MSC full assesment within the perscribed 3-years
- Change practices (no take of small crabs/juveniles, no take of egg-bearing females), increase the stocks, develop policies that protect and sustain crabs (including protection of nursery ground, spawning area) by end of December 2022
- Develop a management plan for Indonesian blue swimming crab that includes community resources management that protects nursery ground; produce a control document by end of December 2018
- Implement FIP workplan that includes development of the management plan, community-based management, communication and awareness, nursery and spawning grounds protection projects, as well as a hatchery project by end of December 2018



Indonesia FIP Status Report

Assessment of the fisheries using three internationally recognized protocols for sustainable sourced seafood. The assessment suggests:



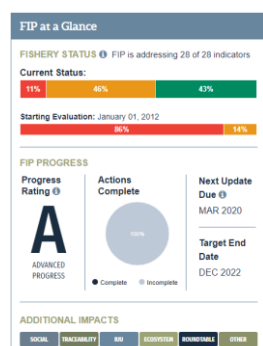
The FIP currently at **SFP Stage 5 : Improvements on the Water** – and Progress Rating got **A (Advanced Progress)**



The blue swimming crab fisheries has been assessed in 2015 using the MSC's Fishery Assessment Methodology (V2.0). Current score SG <60 MSC's standard for sustainable blue swimming crab fisheries



The blue swimming crab fisheries has been assessed using the Monterey Bay Aquarium's Seafood Watch Criteria of capture Fisheries (v2.0)
