































PREFACE

Assalamu'alaikum wr.wb.

All praise and thanks be to Allah, the One True Almighty God. we would like to express our gratitude to all APRI members that they have been entrusted with holding the mandate of Ladies and Gentlemen in the Management of APRI for the 2018 - 2020 Period.

In carrying out this management there are 2 (two) main programs in the Management. The first program is the management and members together discussing and finding solutions to problems in the business sector, whether related to issues on the part of the buyer, the US government, KKP regulations, or other issues. Meanwhile, the second program is related to the sustainability program which we usually know as FIP (Fisheries Improvement Programs). These two main programs are interrelated and cannot be done separately.

In the 2018 - 2020 stewardship period, there was an increase in the number of 4 new members from 12 to 16 members. It can be said that of these 16 members have contributed 85% of the total tonnage of exports to the USA market. During the period Jan-Aug 2020 Urnerbarry recorded imports of pasteurized BSC from Indonesia totaling 18,231,669 Lbs or around 8,277,177 Kg crab meat equivalent to 1,034,647 Kg / month or 58 containers / month departing from several Indonesian ports to the USA . Meanwhile, last year with the same period, namely during the period Jan - Aug 2019 Urnerbarry recorded USA imports amounting to 16,390,694 Lbs or around 7,441,375 Kg from Indonesia. This tonnage is equivalent to 930,172 kg / month or 52 containers / month. So there is an increase of 11.5%.

Meanwhile, the largest contribution of USA pasteurized crab meat imports was from Indonesia, which was around 54.23%. Venezuela is in second place, namely 11.5%. If the estimated average price is USD 9.00 / Lb, the value of Indonesia's exports will be IDR 2.4 trillion up to August 2020. With the extrapolation of the average, it is expected that around 3.8 to 4.0 trillion rupiah in 2020 will be achieved.

Some environmental observers are concerned about the catch of small crabs (Blue Swimming Crab / BSC) in WPP 712 Java Sea. This is only natural because it only looks at picking activity along the coast of Java. The peeling process requires excellent skills, speed, accuracy, water availability and a clean culture in the Mini Plant. However, actually the raw material for crabs is caught with Bubu by fishermen other than WPP 712 as well as from WPP 711 and 713. Some of them are even brought to Java Island. If the export equates to 1 million kg of export meat, it is equivalent to 4,000,000 kg or 4,000 tons / month of fresh crabs that are caught or the equivalent of 133 tons / day.

However, a lot of encouraging evidence. **First** from the scientific research results of APRI enumerators who are located along the central gate to catch small crabs has been presented by Dr. Hawis Madduppa in various regional and national events shows that the majority of crabs caught are> 10 cm and the percentage of crab catches is decreasing.

Second that FisheryWatch, an independent international body, assesses that the Indonesian Rajungan FIP guided by APRI received an A for 4 consecutive years. **Third**, starting in the second semester of 2020 during a pandemic, the sales of Indonesian pasteurized crabs decreased so that the crabs as living creatures could reproduce better. **Fourth**, fishing for small crabs is still in the western part of Indonesia, while eastern Indonesia has the potential to be developed for the empowerment of the people's economy. **Fifth**, the crab cultivation aspect is still in the middle of the road. Cultivation of crab, lobster and shrimp is growing very rapidly. We believe Inshaa Allah, in turn, the crab cultivation will soon be in front of us. We must not be late from other countries that continue to do cultivation technology engineering.

The five points above must be managed properly by APRI together with stakeholders, namely the Central / Provincial / Regency Government, Research Institutions, Institutions / Universities, Suppliers / Mini Plants, Fishermen, Employees and all related parties. By uniting together into a complete unity, the program of nature preservation and business sustainability can be balanced and improved.

Such is the foreword in the APRI Management Accountability Report for the 2018-2020 period which ends today. In addition to the APRI Activity Report, we also convey the organization's Financial Report which is delivered in a strict manner.

Hopefully the management in the future can be better than the current management. The achievement of MSC certification is in sight, the available funds are still adequate, but it needs explanation & transparency in managing MSC International Standards and is fairly accepted by APRI members. Hopefully the beginning of the first semester of next year in 2021, Insha Allah, we will achieve it.

We, on behalf of all APRI administrators for the 2018-2020 period, would like to apologize if there are things that are less damaging to members.




MSC Chain of Custody (CoC) Training

Solidaritas Rajungan 1781945 has already raised funds and distributed them to pickers and small fishermen affected by COVID-19 in most parts of Indonesia.

The Solidaritas Rajungan 1781945 Program involved partners including the Sustainable Fisheries Partnership (SFP) Resources in providing assistance aimed at the blue swimming crab supply chain in Central Java (Pemalang, Demak, Jepara, Pati, Rembang), East Java (Gresik and Sumenep), and Southeast Sulawesi (Konawe Selatan). In the implementation also worked with Community Organizer, Enumerator, dan Fisher Communities.

Distribution of food to the target supply chain was carried out in June 2020 with the total number of packages distributed as many as 637 food packages which was distributed in 3 provinces with total value of Rp 56.126.500.



Online and Offline Training Making Crab Paste"Terasi Rajungan"

July 17, 2020. APRI held a training activity for making crab paste "terasi rajungan" with an online system via zoom and offline on a limited basis by implementing the COVID-19 health protocol. 
Data Management Committee (DMC) - Southeast Sulawesi

Nugroho as APRI Board tell about APRI Milestone and target in 2021, APRI wants to get Marine Stewardship Council (MSC) certification for small crabs explicitly stated that APRI needed support from the government for comprehensive marine research in responding to the demands of the global market, as well as support for the acceleration of FIP towards MSC certification so that Indonesian crabs could not compete with other countries. Furthermore Mr. Ed Rhodes from the NFI Crab Council expressed his full support for APRI in implementing FIP for the improvement of small crab fisheries.

Prof. Rokhmin Dahuri as the first speaker in Q3 webinar session tell The sustainability of raw materials requires awareness of the importance of responsible fisheries and support for small crab cultivation technology. The challenge from a market perspective is increasing, The requirements for crab export, such as food safety quality standards, traceability, and ecolabeling certificates. According to Prof. Rokhmin, the way out of this problem is "Build the spirit of Indonesia Blue Swimming Crab Incorporated" by all stakeholders.



Prof. Sjarief dari BRSDM KP also tell about good idea to development of small crabs in Indonesia based on coastal communities, such as the agricultural concept of "transplanting", where in potential areas (mangroves), restocking is carried out by spreading superior broodstock laying crabs and last speaker Dr. Sri Yanti explained the efforts of Bapennas in supporting the management of crab as a leading Indonesian fishery commodity through the FIP program. Bapenas is collaborating closely with APRI in fighting for the small crabs to get MSC certification by 2021 Dr. Hawis also said "APRI FIP has received a progress rating A, but APRI continues to strive to increase its value, starting point at 0.04 to 0.77 in 2020, is close to reaching MSC".

Hirmen Syofyanto from MSC explained about MSC Fisheries and CoC certifications that can be developed by APRI and its members, and gave an overview of the costs that must be spent for the assessment. Continuing Hirmen's explanation, Roderic Hodges from Marine Change presented the idea of developing a financial model for APRI in carrying out the full MSC assessment. Next Dr. Putu explained APRI and CETASI's research plan in addressing the issue of the impact of small crab fisheries on marine mammals. This meeting very interesting and the topic that needs to be studied more, so the APRI members want to discuss every 2 weeks in bi-weekly for more discuss.

APRI for the third time again provided research scholarships to 5 groups of students from various universities.

In addition to data analysis techniques and methods, Mr. Hawis also conveyed crucial things in fisheries management, namely translating the results of data analysis to all stakeholders (industry, academia, government, fishermen, and others), in other words how to bridge science to management.




Webniar: Establishing HR Through the Fisheries Business



The Role of Fishermen in Ghost Fishing Clean UP!

Unmanned fishing equipment is fishing equipment that is abandoned, discarded, dragged by currents or caught in other fishing gear that can affect life in the sea. Ghost Fishing can have an impact on decreasing the catch or stock availability. The important role of fishermen in the use of sustainable fishing gear will help avoid ghost fishing.

Since October 2020, 3 CO-Management Regions (Rembang, Pamekasan and Pamandati) have carried out this activity with fishermen to maintain the ecosystem and apply sustainable fishing gear. Fishermen can reuse these fishing gear with the principle of recycle, reuse, reduce

Fishermen in Rembang and-Pamekasan are aware of the importance of the sustainability of the marine ecosystem by lifting parts of their fishing gear in the form of ropes, which is part of the "Ghost Fishing Clean Up" program. The ropes found by these fishermen can also affect marine ecosystem life.

The role of fishermen in helping reduce waste and also maintaining the sustainability of the ecosystem is very important with this program, hopefully it can make fisheries management sustainable so that the catch is more abundant.


Protected Area for Blue Swimming Crab

Capit Biru fisherman shop, which has been completed and has started operating, has started to help local fishermen as evidenced by the constant sale of several goods, especially diesel and bait.

The presence of this fishermen shop is expected to continue to provide benefits to the surrounding community in providing materials for fishing purposes and also as an alternative income for KUB Berkah Capit Biru to support their livelihoods, especially in this pandemic.

Scientific data collection research & sampling program

Data Collection

Data collected by enumerators with the area of data collection including several locations, that are Central Java (Pemalang, Demak, Pati, Rembang), East Java (Gresik, Pamekasan), South Sulawesi (Pangkajene dan Kepulauan), Southeast Sulawesi (Pamandati, Kendari). APRI start the data collection since 2014 and now it still continue where there are now 7 locations with enumerators, that is Pemalang, Pati, Rembang, Gresik, Pamekasan, Pangkajene dan Kepulauan, and Konawe Selatan.

Enumerator Training

For better data collection, the enumerators should be trained. APRI train the enumerators at least 3 times in 2018-2020 period. The first training is on 30 November-1 December 2020 in Bogor, the second training is on 9 July 2019 in Semarang, and the third training is on 2 March 2020 in Bogor.

Research Collaboration with Pusriskan

For the stock assessment, APRI collaborate it with Pusriskan. APRI and Pusriskan is on process to signing the Memorandum of Understanding (MoU), especially with Balai Riset Perikanan Laut (BRPL). APRI and BRPL was held the first audience/hearing on 20 September 2020 in Bogor and now the MoU is still in the process.

LBSPR Workshop

The workshop material was given directly by Prof. Jeremy Prince (Biospheric, Australia), expert who developed LBSPR. Prof. Jeremy Prince introduced and trained participants on stock measurement methods that have not been widely used by researchers in Indonesia by integrating length data and biological information such as fish growth, mortality rates, to measure stock status. It held in Bogor, 160-17 December 16-17 2019 which attended by the KKP SDI Directorate, the KKP Marine Fisheries Research Center, NGOs (SFP and EDF), Fisheries and Marine Researchers, from universities and APRI members and staff. This activity aims to update the researcher's information about the crab data processing analysis to support the crab fishery improvement program and how to translate the analysis into a good management strategy.





Scientific data collection research & sampling program

Aquaculture

APRI collaboration with BBBAP Jepara develop the blue swimming crab aquaculture with semi-intensive and silvofishery method, period 2018-2019 located in BBPBAP Jepara. At least there was 2 times of harvesting from this aquaculture, on 19 September 2018 and 27 January 2019.







SEMI INTENSIVE METHOD

APRI also participates in the discussions and communications related to the aquaculture. In 28 August 2020, APRI participates in the webinar organized by BBPBAP Jepara with theme "Sustainable Blue Swimming Crab Management as Prospective Aquaculture Commodity". In this opportunity, Kuncoro C. Nugroho as APRI Chairman presenting the business prospect of BSC development in Indonesia, and Dr. Hawis Madduppa as APRI Executive Director share about the DNA barcoding and BSC aquaculture environment.



Restocking:

As an effort tp increasing the stock, there also restocking activities. In 2019, restocking done on 20 February in Maros, South Sulawesi which which collaboration between one of APRI member PT Kemilau Bintang Timur and BPBAP Takalar. Restocking activity also done in Pamekasan, Madura on 21 September 2020 collaboration between APRI, Bappenas, UNDP which releasing 250,000 crablets.

Egg berried female BSC Apartment:



APRI since 2016 support the development and application of crab box/crab apartment for egg berried female blue swimming crab. It started in Jepara, where the crab box is managed by the fisher community. Crab box/apartment now developed and implemented in 3 other locations, that is Rembang, Pamekasan, and Konawe Selatan which also managed by fisher community accompanied by APRI community organizer.

GTK5! Launching & socialization

Launching

Asosiasi Pengelolaan Rajungan Indonesia (APRI) launched GTK5! (Gerakan Tangkap Kembalikan Sebelum 5 Menit!). This movement is an effort to preserve and sustain the blue swimming crab fisheries in Indonesia. This movement was launched in Pamekasan, Madura on 10 2020, and will be socialized to all Indonesian blue swimming crab fishermen.

The government through the Minister of Marine Affairs and Fisheries Regulation No. 12/PER-MEN-KP/2020 which is a revision of Permen KP No. 56/PERMEN-KP/2016 prohibits the capture of small BSC with a carapace width <10 cm and egg berried female BSC for the sake of realizing the sustainability of blue swimming crab fisheries. However, the small and/or egg berried female BSC are often caught by fishermen. small and/or egg berried female BSC that are accidentally caught must be returned to the sea so that the crab can be preserved.

To support the return of small and/or egg berried female BSC to the sea after being caught, APRI conducted a movement called GTK5!. This movement is intended so that fishermen can implement the return of small and/or egg berried female BSC with a period of less than 5 minutes after catching. This is to reduce the risk of death of the crab and for a sustainable blue swimming crab fisheries. Socialization

The socialization of GTK5! continues to be carried out to fishermens. In the 7 locations of APRI enumerators (Pemalang, Pati, Rembang, Gresik, Pamekasan, Pangkajene dan Kepulauan, Konawe Selatan), it socialized by enumerators to the bottom supply chain. It is also reinforced by banner installations and flyer distributions especially in the strategic locations of blue swimming crab fisheries. Installations of banner also supported by the fishermens, collectors, mini plant owners, and other players in blue swimming crab supply chain. It hoped that the GTK5! program can be implemented well by fishermens so that the sustainability of blue swimming crab is better.



Risk assessment to determine vulnerability of retained species bait and bycatch species to over-fishing

Risk-based framework (RBF) assessment workshop for Madura waters conducted on 9-10 July 2019 in Surabaya. It participated by various stakeholders such as the Agency of Marine Affairs and Fisheries around the Madura and the blue swimming crab supply chain such as fish processor unit, suppliers, and fishermens. This workshop collected informations about the fishing gear and the animal presence around the Madura and Gresik waters.


For the assessment, data that collected by APRI and data that obtained from this activity processed by Dr. Ir. Zairion, M. Sc. from IPB University to create a risk-based framework assessment report which is currently producing the draft report.


Non-target species assessment

Data Collection Non-target species data collected by enumerators with the area of data collection distributed in 4 provinces, that are Central Java (Pemalang, Pati, Rembang), East Java (Gresik, Pamekasan), South Sulawesi (Pangkajene dan Kepulauan), Southeast Sulawesi (Konawe Selatan). NTS data collected by enumerators together with data collection for biology of blue swimming crab.

Marine mammals research plan with CETASI

The export market for BSC products is dominated with about 85% supplied to the United States. Some time ago there was an issue regarding the application of regulations from NOAA for BSC fisheries products related to the Marine Mammal Protection Act (MMPA). APRI moved quickly by holding discussions with CETASI to learn more about the relationship between marine mammals in the BSC fisheries. The initial discussion, which was held on July 29, 2020, was a sharing of information regarding the small crab fishery and what APRI has done in guarding sustainable crab fisheries. In addition, it also discusses how the impact of small crab fisheries on marine mammals. APRI and CETASI then held another online discussion on 9 September 2020 to discuss the development of the research plan and other matters that need to be discussed in the context of research planning.









Genetic studies

for management unit & risk assessment

DNA Barcoding Training

APRI Executive Director Dr. Hawis Madduppa give a training about biota identification technique by DNA barcoding on 25 September 2019 in Jakarta. This training delivered to 17 blue swimming crab processors and Technical Implementation Unit of Fish Quarantine, which was conducted by Center of Quality Control, Center of Fish Quarantine, Quality Control and the Safety of Fisheries/Badan Karantina Ikan, Pengendalian Mutu dan Keamanan Hasil Perikanan (BKIPM). The training is a part of BKIPM event that is The Review of Fisheries Product Health Certification System.

Vessel Tracking System (VTS)

Applied on the fishermen vessels/boats in 3 locations that are Rembang, Pamekasan, and Konawe Selatan. The vessel tracking system using "TREKfish" which made by Prof. Dr. Ir. Indra Jaya, M. Sc. and team from IPB University. The distribution and installation of TREKfish in Rembang is on 20 August 2019 and follow with Pamekasan in 21 August 2019. And for Konawe Selatan, it distributed and installed on 6 Oktober 2020. Currently, it still use to record the vessel movement where the maintenance and reporting in the field done by APRI community organizer.



Fishing ground & conservation area

The implementation of vessel tracking system, can be introduced as the initial step to obtain the fishing ground locations and conservation area plan. Vessel tracking system able to provide the fishing activity, fishing effort, trips with catching data, and the location of egg berried female and undersize blue swimming crab catch by fishermens.



APRI YOUTH INNOVATION

Collaborative management is indispensable in Indonesia blue swimming crab fisheries. APRI realize it and initiated to involving the university with APRI Youth Innovation program which is held every year since 2018. APRI Youth Innovation is a program that give an opportunity for the student to get the research grant. The research ideas is about the sustainability of blue swimming crab in Indonesia related to sustainable blue swimming crab stock, minimizing environmental impact, habitat assessment, effective management, aquaculture, etc.



Control Document & Audit System


A supply chain device that is used to support the implementation and compliance with the rules that apply to Indonesian crab fisheries, while at the same time improving the quality of exported crab products.

Control document audit conducted on January 2019-February 2020 on 17 APRI members. Audit focusing on the mini plant with checking the compliance of the document, Minimum Legal Size (MLS), and Egg Berried Female (EBF).





Asosiasi Pengelolaan Rajungan Indonesia (APRI)/Indonesian Blue Swimming Crab Association as an organization which is focusing on the sustainability of blue swimming crab fisheries always developing the programs to realize it. In this time, APRI try to get the Marine Stewardship Council (MSC) certification for the sustainability of the blue swimming crab resources and industry. Previously, MMAF and MSC had signed MOU on 27 August 2019 regarding support for enhancing capture fisheries and sustainable markets in Indonesia. And it continued by the preparation of Annual Work Plan/Rencana Kerja Tahunan (RKT) 2019-2022 between MSC and local government in the location of the activity that is East Java, South Kalimantan, West Nusa Tenggara, Maluku, and Bali on 1-2 October 2019in Jakarta. MSC certification itself is an ecolabel which is showing that a seafood product was fulfill various criterias for sustainability. In order to realize the MSC certification for blue swimming crab fisheries, APRI done the MSC pre-assessment in Madura. Blue swimming crab fisheries being one of the fisheries that pre-assessed through the Fish for Good funding. The site visit for pre-assessment proses conducted on 18-20 October 2019 with take place in Madura Island, especially in Bangkalan and Pamekasan District. Currently, APRI has done the MSC pre-assessment. The recommendation from pre-assessment has presented by Conformity Assessment Bodies (CABs) with MMAF and APRI on 18 June 2020. The recent activities is the preparation of action plan from the recommendation. The first step is socialization and coordination with local government, formation of working group, and preparation of action plan document. And MSC full assessment is expected on 2021.












FISHERY IMPROVEMENT PROGRAM (FIP)

The organization APRI - whose members include over 30 seafood industry businesses and processors - covers more than 85% of purchased crab in Indonesia. All members involved are working to promote not only sustainable crab harvest, but a sustainable supply chain as well. The FIP aims to support scientific research through collaborations with universities, to develop a national Fishery Management plan through a partnership with the Ministry of Marine Affairs and Fisheries, and to establish community based fishery management by working with local fishing communities. The FIP is meant to have a lasting impact on the sustainability of the fishery's supply chain, on blue swimming crab resources, and also on the ecosystem where the species is harvested.

FIP Objective(s)

- Work plan and transition Indonesia Blue Swimming Crab Fisheries to MSC full assesment within the perscribed 3-years
- Change practices (no take of small crabs/juveniles, no take of eggbearing females), increase the stocks, develop policies that protect and sustain crabs (including protection of nursery ground, spawning area) by end of December 2022
- Develop a management plan for Indonesian blue swimming crab that includes community resources management that protects nursery ground; produce a control document by end of December 2018
- Implement FIP workplan that includes development of the management plan, community-based management, communication and awareness, nursery and spawning grounds protection projects, as well as a hatchery project by end of December 2018
