## About APRI

APRI and all members are campaigning sustainability crab harvest to the supply chain for effective impact, increasing crab recruitment through stock enhancement, collaborating with Universities to support scientific research, supporting Ministry of Marine Affairs and Fisheries to develop national Fishery Management Plan and working closely with Fishers community to establish community based fishery management. All project activities are managed in a Fishery Improvement Project (FIP), which determined as 6 FIP stages. Fishery Improvement Project will create sustainable impact to the supply chain, blue swimming crab resources and also to the ecosystem where the blue swimming crab harvested.

Saturday, December 7, 2024. APRI has carried out routine activities every quarter and 2024 will be the last year of the APRI chairmanship for the 2023-2024 period.

Other routine activities include the presentation of FIP and APRI Activities by Dr. Ayu Ervinia as Research and Executive Director of APRI and continued at the APRI National Conference (MUNAS).

This APRI MUNAS activity was moderated by Mr. Ir. Bambang Arif Nugraha, MBA in the formation of the formator team until the next term's chairman was determined. Representatives of the formator team in this MUNAS activity were from PT. Bumi Menara Internusa (BMI), PT Muria Bahari Indonesia (MBI), and PT. Fresh On Time Seafood (FOTS).

In addition, this activity was also attended by academics, business actors, and representatives from each region from East Java province who were active in discussions related to crab fisheries management.




## APRI Expert Council Figure at Crab Management Meeting in East Java Province

Bandung 24 – 25 February 2025. APRI also attended the TPPRB meeting in West Java Province. This activity was also attended by several APRI members who are business actors.




### APRI Meeting with NFI Crab Council at Boston Seafood Expo America Event


### A. Spawning Potential Ratio (SPR)

**(1). The SPR value of crab varies between 16-34% (2). The highest SPR is in Pemalang (Central Java) and Lampung, which reached the SPR reference point target of 30%. (3). Several locations such as Cirebon, Gresik and Pamekasan show SPR values <20%.**



FIP aims to support scientific research through collaboration with universities, to develop a national Fisheries Management plan through partnership with the Ministry of Maritime Affairs and Fisheries, and to build community-based fisheries management by working with local fishing communities. The FIP is intended to have a long-term impact on the sustainability of the fishery supply chain, the crab resource, and also the ecosystem in which the species is caught.

## FIP Objectives

- Implement the FIP work plan and transition Indonesia Blue Swimming Crab Fisheries to full MSC assessment by the end of December 2025.
- Changing practices (no taking small/juvenile crabs, nor spawning crabs), increasing stocks, developing policies that protect and maintain sustainable crabs (including protection of nursery grounds, spawning areas) by the end of December 2025.
- Develop a community-based management plan for the Indonesian blue swimming crab that includes community resource management that protects the nursery, communication and awareness, resulting in a control document and an established traceability system by the end of December 2025.
